The aim of this Workshop is to present and discuss the latest legal and regulatory developments affecting European club football, including the UEFA Disciplinary Regulations, the FIFA Regulations on the Status and Transfer of Players and case law of the Court of Arbitration for Sport.

Selected legal experts representing UEFA, ECA and clubs will update participants on the latest trends and share opinions on how they perceive the legal framework in European club football moving forward.

To make the Workshop as practical as possible, two breakout sessions will be held on the topics of financing transfers and commercial agreements in football.
