7. Euro 2008 SA shall not be required to accept any proposal submitted in response to this invitation and reserves the right to organise any services related to the uniforms for UEFA EURO 2008™ itself or to re-open the invitation to tender at a later stage.
8. This statement of undertaking, the selection procedure and any related documentation shall be governed by, and construed in accordance with, the substantive laws of Switzerland. Place of jurisdiction shall be Nyon, Switzerland.
