

Privacy Notification

2019 UEFA Youth League™ Final Tournament

You have provided, are about to provide or will provide personal data of data subjects to UEFA, acting as data controller, via the 2019 UEFA Youth League™ Final Tournament ticket purchase form and/or in accordance with the 2019 UEFA Youth League™ Final Tournament Ticketing Terms and Conditions) (the "Terms and Conditions").

The personal data are collected and processed for providing the data subject with a ticket supply and in this respect for organising and running the ticket sales for the matches of the 2019 UEFA Youth League™ Final Tournament™ and/or for the purposes of any relevant safety and security measures related to the Match (as defined in the Terms and Conditions).

Where required for the purpose of the organisation of the Match and/or for the purpose of any relevant safety and security measures, UEFA may transfer certain personal data to UEFA's service providers and third parties, in particular to Stadium (as defined in the Terms and Conditions) security and access control service providers and the Stadium Owner (as defined in the Terms and Conditions) (and their agents) who perform functions on UEFA's behalf. Certain personal data may also be transferred to the relevant authorities for the purpose of safety and security measures related to the Match. UEFA will implement appropriate safeguards in the event of a transfer of personal data to the parties identified above located in a country which does not ensure an adequate level of protection within the meaning of European Law.

The personal data are processed on the basis that such processing is necessary for the performance of the contract entered into between UEFA and the data subject, for the legitimate interest of determining eligibility of persons interested in purchasing Ticket(s) and ensuring Tickets delivered to the right data subject, as well as of guaranteeing an effective security system inside and around the Stadium, and combatting the unlawful sale of Tickets.

You understand that the personal data will be available to UEFA, including its subsidiaries and any third party appointed by UEFA to assist in the organisation of the Match.

IF YOU SUBMIT PERSONAL DATA ON BEHALF OF OR FOR OTHERS, YOU CONFIRM HAVING INFORMED THE DATA SUBJECT OF THE CONTENT OF THIS PRIVACY NOTIFICATION PRIOR TO DATA CAPTURE. YOU ACCEPT THE RESPONSIBILITY OF INFORMING EACH PERSON OR ENTITY OF THESE RULES AND PROCEDURES. UEFA IS ENTITLED TO REQUIRE AT ANY TIME EVIDENCE OF THE PROVISION OF SUCH INFORMATION.
