

## Privacy Notification

### **2018-2019 UEFA Youth League™ Finals Ticketing Terms and Conditions for Football Scouts**

You have provided or are about to provide personal data of data subjects to UEFA, acting as data controller, on its Football Administration and Management Environment (FAME).

The personal data are collected and processed for the purpose of providing the data subject with a ticket permitting access to the stadium for a match(es) of the 2018-2019 UEFA Youth League™ Finals in Nyon (the "Finals") and in this respect for organising and running the ticket allocation process for the Finals and/or for the purposes of any relevant safety and security measures related to the Finals.

Where required for the purpose of the organisation of the Finals (and/or any specific match of the Finals) and/or for the purpose of any relevant safety and security measures, UEFA will transfer certain personal data to its service providers and third parties, in particular to stadium security and access control service providers who perform functions on UEFA's behalf. Certain personal data may also be transferred to the relevant authorities for the purpose of safety and security measures related to the Finals. UEFA will implement appropriate safeguards in the event of a transfer of personal data to the parties identified above located in a country which does not ensure an adequate level of protection within the meaning of European Law.

The personal data are processed on the basis that such processing is necessary for the organisation and administration of the ticketing allocation process, for ensuring that tickets are delivered to the right data subject, as well as ensuring an effective security system inside and around the stadium and for combatting the unlawful sale of Tickets.

You understand that the personal data will be available to UEFA, including its subsidiaries and any third party appointed by UEFA to assist in the organisation of the Finals.
