UEFA Control & Disciplinary Body decisions

UEFA's Control & Disciplinary Body fine Real Madrid CF and FC Barcelona

The decisions of the UEFA Control and Disciplinary Body meeting of Thursday 11 July 2002, at the House of European Football in Nyon, Switzerland, have today been made public.

FC Barcelona were fined 25,000 Swiss Francs and Real Madrid CF 15,000 Swiss Francs for incidents that took place during the UEFA Champions League match of 01 May 2002. FC Barcelona were fined due to the incorrect behaviour of their supporters, throwing a number of Bengal lights towards the Real Madrid CF supporters. Real Madrid CF were fined due to the incorrect behaviour of their supporters and the unsporting behaviour of the ball-boys. Both clubs have until Monday 15 July at 24:00 hours CET to appeal against the decisions.

The Control & Disciplinary Body also fined Fabien Barthez, of Manchester United FC, 5,000 Swiss Francs for punching and damaging the players tunnel following the match against Bayer 04 Leverkusen in the UEFA Champions League on 30 April 2002.

Other main decisions taken by the Control & Disciplinary Body included; the fine of 25,000 Swiss Francs against Feyenoord for numerous incidents involving the lighting and setting-off of Bengal fireworks during their UEFA Cup match against BV Borussia Dortmund on 08 May 2002 and the fine of 10,000 Swiss Francs against the Swiss Football Association for the incorrect behaviour of their supporters in the under-21 match against France.
